CALLING ALL GRUNIONS

We are excited to announce that we will be accepting applications for the team's sponsorship program for IGLA 2023 to be held in London, UK from June 25th to 30th, 2023. We are anticipating this year's awards to be \$500 per recipient. Total number and the exact amount of the sponsorships to be awarded for 2023 IGLA Championship will be determined based on the qualified applicants as well as the amount of funds allocated for the 2023 Grunion Sponsorship.

We value the time and team commitment that many Grunions give throughout the year and will be awarding sponsorships based on the following criteria:

- Number of days volunteered at IGLA 2022 Palm Spring
- Number of days volunteered at SPMS SCM Championship (LBCC meet)
- Number of events registered to swim at IGLA 2023 London

Here are the requirements to be eligible for the sponsorship award program:

- 1. Monthly dues paying member for at least 6 months on application submission date, 2023. The 30 day trial period is considered to be in good standing for this purpose.
- 2. Registered to swim at IGLA 2023 London.
- 3. Must be available to swim all team relays on the days that you are registered to compete.

The sponsorship money will be paid in the following manner: 50% of the award upon your acceptance of the terms of the sponsorship, and the remaining balance within 30 days of the completion of the event pending verification of all terms of the sponsorship have been met.

We will accept your sponsorship application from <u>Feb 1, 2023 to April 17, 2023</u>. If you are selected for the award, you will be notified via e-mail by May 1, 2023.
